4. PRESIDENT'S REPORT
Mr. A. Badino (France), Vice-President C.I.V.L., resigned during the year.
C.I.V.L. Bureau met in Kössen in March 1985 for following matters :
a) World Championship 1987 Canada/Australia (see item 8).
b) Local regulations for World Championship 1985. (It was pointed out that no changes should be made after final acceptance of local regulations).
c) Mr. S. Himberger acted as C.I.V.L. delegate for olympic matters during F.A.I. General Conference 1984 in Prague.
5. WORLD CHAMPIONSHIPS 1985
 - Minor problems with interpretation of local regulations.
 - World Championships 1985 were the best ones in the history of Hang Gliding/FAI, 30 official nations, 210 pilots, 1400 flights, + 2000 hours, 48,500 km total distance during the competition (without training).

7. EUROPEAN CHAMPIONSHIPS 1986 IN HUNGARY
 - Final draft of local regulations discussed.
 - Several changes proposed by C.I.V.L.
 - Final acceptance of local regulations delegated to C.I.V.L. Bureau.
8. WORLD CHAMPIONSHIPS 1987
 - Canada withdrew its bid in favour of Australia.
 - WC 1987 will be held in Australia (December 1987)
 - Acceptance of local regulations during next C.I.V.L. meeting
 - No guarantee that participation of South Africa will be accepted by Australian Government.

9. FUTURE CHAMPIONSHIPS

Provisional bids received from : Italy (EC 1988), Yugoslavia and Czechoslovakia (EC 1990).

Verbal provisional bids received from :
Switzerland (WC 1989), France (WC 1991).

Bids (including provisional) only to be accepted by C.I.V.L. when accompanied by official documents of NACs concerned.

10. OLYMPIC GAMES

Mr. Larcher (F.A.I.) informed C.I.V.L. about actual stand of discussions with I.O.C.

President of IOC shall be invited to one of the upcoming EC or WC in Hang Gliding by C.I.V.L. Bureau.

11. NOMINATIONS FOR F.A.I. HANG GLIDING DIPLOMA 1985 : none

12. OTHER BUSINESS

a) In accordance with F.A.I. Sporting Code, General Section 4.5.4., C.I.V.L. decided to compose the International Jury for future Championships as follows :
One Chairman of the Jury (elected by C.I.V.L.)
Two arbiters (nominated by organising NAC, appointed by C.I.V.L.)
Arbiters shall not hold any position in a participating team or in the organisation of the Championships.

b) The following new paragraph shall be included in the F.A.I. Sporting Code, Section 7, after acceptance by C.A.S.I. and F.A.I. General Conference :

Article 6.2.11. : International Jury

It is the responsibility of the Jury to ensure that the provisions of the General Section and Section 7 of the F.A.I. Sporting Code as well as the Local Regulations of World or Continental Championships are strictly observed and followed (4.4.4, 5.4.4, 4.6.4).

c) C.I.V.L. decided to restrict the "8 month rule" (3.7.3) to a minimum of 6 months (to be approved by C.A.S.I.).

d) Recommendations of C.A.S.I. (meeting 19/20th February 1985) :
- C.I.V.L. addresses his warmest thanks to C.A.S.I. for all assistance.
- Paragraph 4.2.7 : the wording of the ment. paragraph covers both winch-towing and aero-towing and shall therefore not be changed.
- Paragraph 6.2.3 : C.I.V.L. agreed with C.A.S.I.'s recommended clarification.
