Extended Time Limits

If no bids have been received at the two year point the plenary may vote to extend the bidding period for a further 6 months, until the end of September.

At the end of September any ensuing bid file must be presented to the CIA Event Development Service (EDS) for evaluation.

EDS will recommend to the Bureau by the end of November, that any received bids are accepted or rejected, and that the accepted bids shall be added to the agenda of the next Plenary meeting which would take place12 months before the event.

Voting by the Plenary to award the organisation of the event shall be by secret ballot and simple majority.

Intentions to Bid

- Intentions to bid must be received by the CIA at least 60 days before the date fixed for the CIA meeting three calendar years before the year scheduled for the Event. They shall be included in the Agenda of that meeting.
- Exceptionally, and only if the CIA has received less than 2 intentions to bid in accordance with the three-year deadline, the CIA may accept intentions to bid up to 60 days before the date fixed for the CIA meeting two calendar years before the year scheduled for the event.
