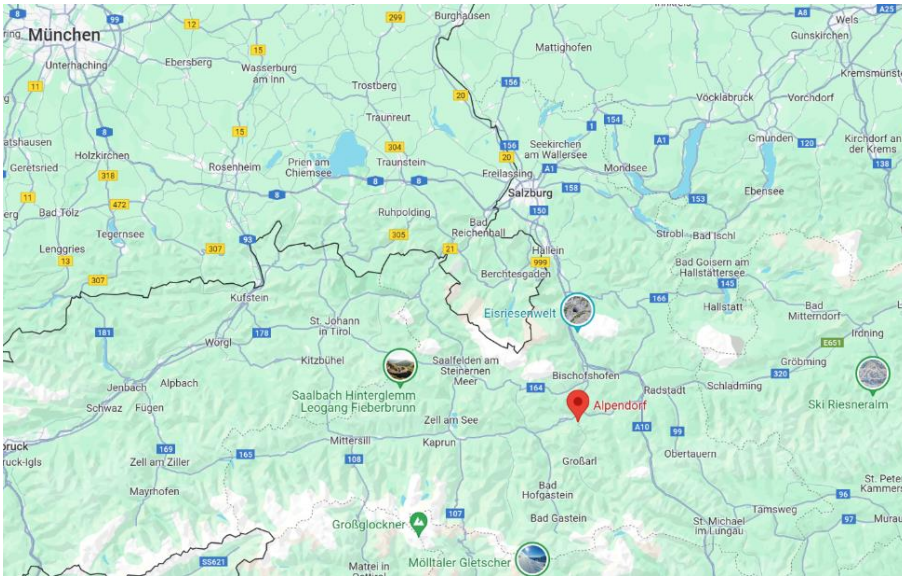

4 TRANSPORTATION

Competitors are responsible for their own transportation to and from the competition venues.

Local transportation may be provided upon request on the final entry form.

To be paid depending on the distance to the chosen accommodation (not included in the competition entry fee).

Judges and FAI officials will be picked up at their arrival Airport/Train station (organized by the Assistant to the Chief Judge upon request). Local transportation for Judges will be provided during the competition.

5 ENTRY: FEES & REGISTRATION

5.1 ENTRY FEES WILL BE AS FOLLOWS (ALL IN EURO)

* the CHF sanction fee will be converted to € right after ISC Plenary and all NACs that have submitted a provisional entry will be notified about the applicable amount, so the whole entry fee can be paid in one € bank transfer.

Entry fee covers

For Competitors:

- 6 Competition jumps and final jump, Re-jumps
- Opening ceremony
- Closing ceremony
- Banquet
- Ski race
- Ski pass for the Ski race
- Competition Souvenir Bag

For Officials and Accompanying persons:

- Opening / Closing Ceremony, Banquet, ski-pass for 3 days (St.Johann only)

Entry Fee does not cover

- ISC sanction fee
- Accommodation, meals, transport

Disciplines to be contested

Parachute-Ski according to ISC PS Competition Rules.

- 6 accuracy jumps, 1 final jump
- 2 giant slalom runs with starting order as in PS CRs 5.2.2.2

5.2 ENTRY DATES

(for provisional and final registration, see SC5 4.4.1.)

- Provisional registration must be received by **20th December 2024**.
- Official registration and payment must be received latest on **6th of February 2025**
- Late registration may be accepted if capacity allows, and the registration fee will be increased by 20% (except the sanction fee which stays the same).

5.3 NUMBER OF TEAMS ALLOWED

as specified in PS Competition Rules.

(PS CRs 7.3.4 The teams may be all open (male), all female, or of mixed gender. There may be no more than 8 open (male) or 8 female competitors in these teams. An additional team may be composed of only juniors, or for each junior included in the teams mentioned above, this team may include one competitor of the same gender, who is not a junior. For a team to be eligible for Junior Team ranking, it must be composed of 4 junior competitors.)

All competitors of the World Championships are also ranked in the World Cup Series.
Note: If a NAC has more than this number of competitors they may participate in the World Cup Series, which will be held parallel to the World Championships. See <https://parachute-ski.com/>

5.5 REGISTRATION PAYMENT PROCEDURE

Once registration is done you will receive an invoice and can choose between:

- a) Credit card payment. All major credit cards will be accepted, but subject to a 3% booking fee per registrant.
- b) Bank transfer. Only after transfer has been received is registration considered to be complete. Any bank charges for wire transfers will be the responsibility of the sender.

The whole amount as per the section 5 Entry: Fees & Registration must be paid to the organizer.

Details to the ski race and parachuting sites:

In Sankt Johann-Alpendorf, there are two options for the ski race and two options for the parachuting competition.

Ski race run – **option 1** (see below):

To get to this area, participants have to take 2 other lifts first.

Difference in altitude: approx. 268 m Length of Run: approx. 60 sec

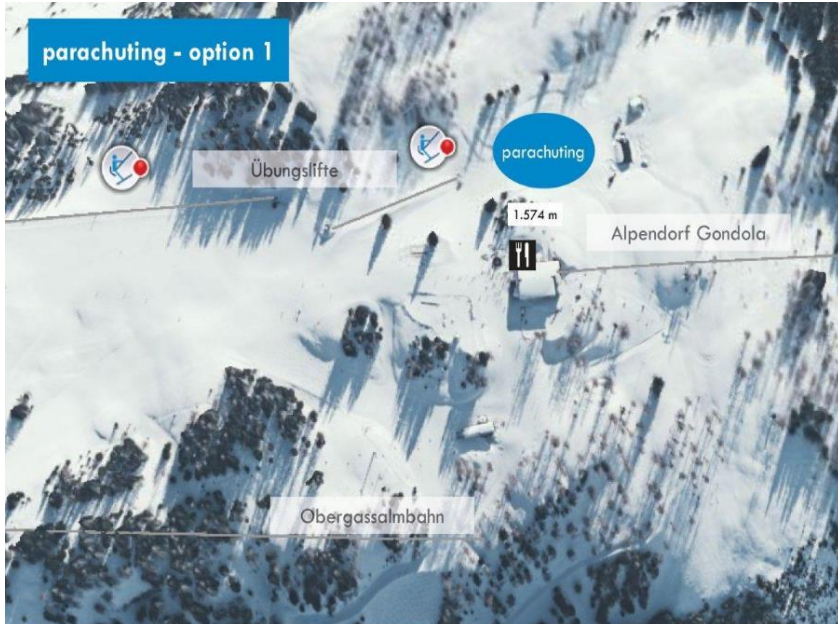
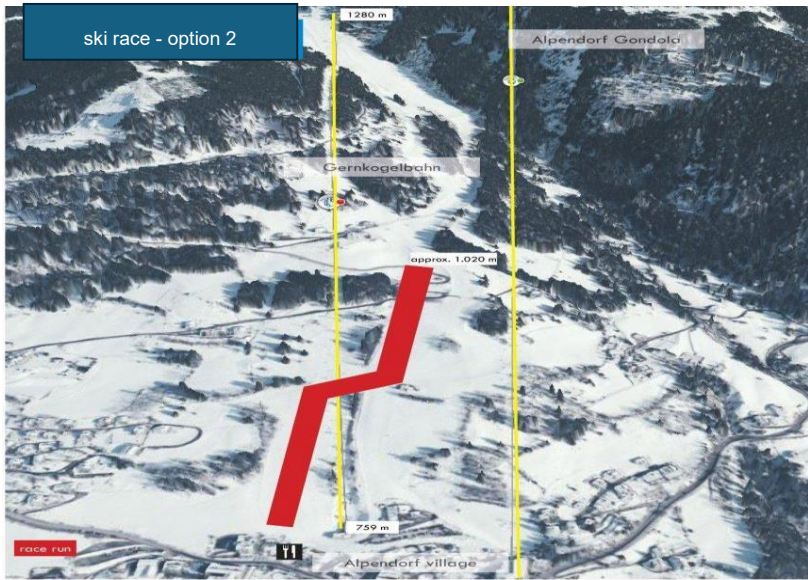
Ski race run – **option 2** (see below):

Start: approx. 1020 m above sea level Finish: 759 m
Difference in altitude: approx. 261 m Length of Run: approx. 60 sec

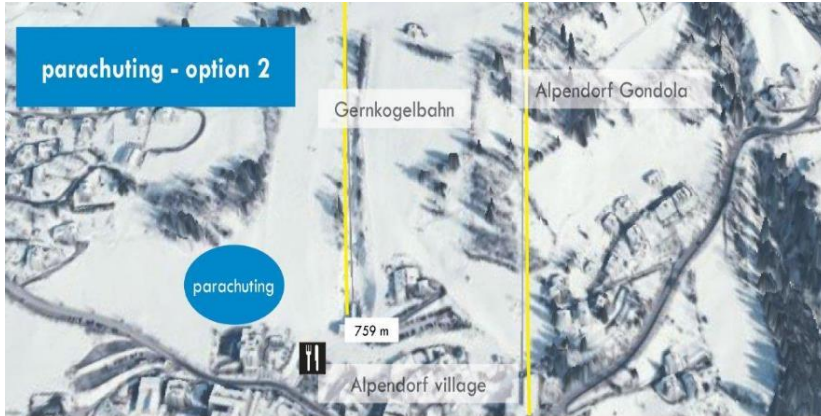
Parachuting target area – **option 1** (see below): Altitude: 1.574 m

10 EQUIPMENT

10.1 SAFETY

Helmets are mandatory for all competitors.

AADs are required.

Fully opened parachute must be at minimum of 600 AGL.

Reserve Parachute Repacks according to each participant's national regulations.

10.2 LEGAL REQUIREMENTS

A skydiving licence which is valid to jump in AUSTRIA is required by law. Not all national licences are accepted automatically and need to be validated latest at the registration office. In case of doubt, contact the organizer in advance

For 3rd party liability insurance see #14 - Insurance Details

10.3 FAI SPORTING LICENSE

A valid FAI Licence for 2025 is required, and each competitor must be listed in the FAI Sporting License Database 1st of March 2025 latest.

On site communication in addition to the official info board will be via WhatsApp to all Team Managers and/or to one designated official representative for each participating NAC delegation.

13 MEDICAL / EMERGENCY DETAILS

The Organizing Committee will provide Ski Patrol of the Ski Area as medical first responder on site. Safety plan is in force.

Nearest hospital is in SCHWARZACH/St. VEIT (7 km/ 10 minutes by car).

14 INSURANCE DETAILS

Personal medical & repatriation is the responsibility of each participant. First Aid and Ambulance will be available, any costs associated with medical care are to be covered by the concerned participant.

Medical & repatriation insurance is recommended, but not mandatory.

Third party liability with coverage for situations not covered by SC 5, 4.5.3 (2) is required by Austrian law, the required minimum coverage is € 1.5 mio.

If requested at the final entry, the organizer can assist with contacts to national insurance providers.
